WARRANTY STATEMENT AND CONDITIONS OF SALE

This warranty statement shall be effective in lieu of all other warranties expressed or implied.

Helmel Engineering Products, Inc. guarantees that its manually operated, and DCC Coordinate Measuring Machine Systems will be free of substantial defects in materials and workmanship under conditions of normal use and care for a period of one (1) year from the date of initial installation less a period equivalent to the non-payment over-term. We reserve the right to replace or repair, at our option, any part found defective, including all mechanical components, drive systems, drive electronics and scales, without cost to the buyer, provided that the defective part, component or assembly be returned to **Helmel Engineering Products, Inc.** with transportation costs prepaid both ways, and that adequate repair or replacement time be allowed.

Helmel Engineering Products, Inc. must be notified immediately of any warranty claim and reserves the right to personal inspection by its staff or appointee. Helmel will require a Purchase Order to cover travel and living expenses when on-site warranty service is deemed necessary, prior to initiating such service. These expenses will not be charge if we determine that customer's claim is warrantable.

Helmel Engineering Products, Inc. shall consider this warranty void if:

- 1) Customer staff have not completed Helmel Authorized operator training.
- 2) The machine is maintained or operated with protective covers or wipers removed.
- The buyer in any way attempts to repair or modify any component or assembly or a machine without expressed written permission from Helmel Engineering Products, Inc.
- 4) The buyer subjects the machine or any part thereof to any condition which may be considered abusive, such as excessive vibration, or any application not inherent to the nature of the machine, including operation by improperly trained people.
- 5) Parts subject to natural wear become defective due to such wear.
- 6) The machine is serviced by anyone other than Helmel personnel.

Helmel Engineering Products, Inc. shall not be held liable for any cost, loss, material damage or bodily injury resulting from the use of its machine or by failure of any component, assembly, etc. of its machine, or for any of the aforementioned effects arising from the installation or repair of our equipment.

Helmel Engineering Products, Inc. does not intend to suggest with this warranty the elimination of reasonable, regular and preventative maintenance, or elimination of our recommended annual service and calibration of Helmel CMM systems.
